## **Surescripts Terms and Conditions**

- 1. **SUBLICENSE.** Surescripts LLC ("Surescripts") hereby grants to end-user ("End-User") a limited, nonexclusive, and nontransferable right and license, without the right to grant sublicense, solely in the United States, to access the functionality of the Surescripts Prescription Benefit and History Service ("Surescripts System") through Evident, LLC, subject to a written agreement between Evident and End-User, for the sole purpose of transmitting and receiving information relating to that functionality from other Surescripts System participants (collectively "Participants"). End-User acknowledges that Surescripts owns the Surescripts System subject to the sublicense.
- 2. **CONFIDENTIALITY.** End-User agrees that it shall protect and keep confidential all Surescripts and Participant confidential information, including without limitation, Surescripts patents, copyrights, and trade secrets and any information made available to End-User by or through the Surescripts System.

- 4. **DATA USE.** End-User warrants that it will under no circumstances use or allow any use of any data accessed by the End-User through the Surescripts System other than for the specific purposes such data is provided.
- 5. **AUDIT.** End-User will allow Evident and/or Surescripts to access, inspect and audit records of the End-User relating to the use of the Surescripts System, Surescripts confidential information and data or information provided by Participants.
