★ TEXAS 78th LEGISLATIVE SESSION 2003 ★

The EYES of CWA Texans are upon the following items:

Defense of Marriage

Our top priority is the passage of a Defense of Marriage Act (DOMA). The DOMA legislation will protect Texas marriage laws so that civil unions or homosexual “marriages” from other states will not have to be honored in Texas.

Prenatal Protection

This bill provides criminal penalties for the assault or murder of an unborn child. There is no law in Texas that allows a person to be criminally prosecuted for the killing of an unborn person.

Ban on Human Cloning

A Ban on Human Cloning bill will be filed. Given the inaction by the U.S. Congress, the legislation is most pertinent in Texas. Sen. Jane Nelson filed the bill in the last session and may file it again.

Parental Rights

Protecting parental rights is always a focus of CWA. The government continues to try to usurp parental rights, especially in education and health care. We will monitor legislation to determine if parental rights are being transferred to government agencies.

Choose Life License Plates

CWA of Texas supports a bill to approve license plates that carry the words “Choose Life.” Fees charged for the special plates will be given to crisis pregnancy care centers to promote adoption.
