Prior to his recent tenure as Mexican Ambassador to the United Nations and as a member of the UN Security Council, Adolfo Aguilar Zinser held various positions within the Mexican government. He has been a federal senator and congressman, and in 2001 served as President Fox's National Security Advisor. 4. Intelligence Analyst, SAIS (for NSA):

Imagery, All-Source Intelligence Analyst or Operations technician supporting the Defense Intelligence Agency. The position requires direct support to the Deputy Director for MASINT and Technical Collection. Requires willingness to deploy to Bahrain for up to 30 days at a time in support of the Iraq Survey Group. Responsibilities include training, test plans, CONOPS development, and analysis of technical systems and data. The position requires the development, analysis and understanding of system capabilities, operational requirements and understanding the collection management cycle and making collection recommendations. Additionally, tasks include the coordinating with systems acquisition organizations, developing integration or implementation plans, defining collection plans, and evaluating general collection requirements. Individual will be part of a close-knit team to develop air and ground based MASINT collection-related tactics, techniques and procedures, and use the intelligence architectures as directed by the government.
