Any changes made by this addendum to said plans and specifications offset only the portion of the plans, words or paragraphs specifically mentioned herein, and the balance of the plans and/or specifications remain in full force. 5.01	Summary of Work Section 01010.1.5.A and Dredging, Section 35023.3.3.C.2	The Bureau of Parks and Recreation working with Bureau of Environmental Services will obtain a discharge permit and monitor as needed for water going into Combined Sewer. Contractor remains responsible to meet Total Suspended Solids content at not more than 300mg/L per Bid Specifications, section 35023.3.3.C.2. Monitoring of TSS to be by Parks working with BES.
5.02	Bid Book, Specifications	Contractor has the option to deposit dredged material at the City's Thomas Cully property at no disposal cost. This is the former Killingsworth Fast Disposal land fill with the entrance at 5690 NE 75 th Avenue (just off of NE Killingsworth). Contractor to be responsible for all costs associated with hauling to this site. Contractor will be issued a key and will be required lock up after 3:00 p.m. on weekdays and on Saturdays.
5.03	Specifications Sections 352023.3.1.C and 352023.3.3.A & C.1	Lined or watertight dump trucks are not required as long as soil can be transported and the material will not slosh over the edges and the transportation of material over city and state roads will still meet the regulations governing transport of material. Contractor is responsible for making sure material is transportable in open bed dump trucks and is still subject to regulations governing transport of material and clean roads.

5.04	Bid Book, Description of Work	Contractors are allowed to work Saturdays 8:00 a.m. to 5:00 p.m. The exceptions are:
		Hours will be 8:00am to 4:00pm for the following days: Saturday August 7th, Saturday August 14 th , Saturday August 21 st , and Saturday August 27.
