

# Recruiting Cal/OSHA Safety and Health Inspectors



The California Division of Occupational Safety and Health (Cal/OSHA) is hiring safety and health inspectors throughout the state. These are field positions that conduct compliance inspections in many different settings and consult with employers on a wide range of health and safety issues.

Cal/OSHA inspectors describe their jobs as interesting and enjoyable. They report enormous satisfaction knowing they are helping to improve safety and health conditions in workplaces, aside making a positive difference in the lives of working men and women. In addition, the State of California offers long-term job security and excellent benefits, such as medical coverage and a pension. Examinations are offered for the classifications listed below. Candidates must meet the minimum qualifications, possess strong analytical and communication skills, be able to prioritize tasks and meet multiple demands and deadlines. Bilingual candidates and candidates with combined safety and industrial hygiene experience are encouraged to apply.

<b>Associate Industrial Hygienist</b>	\$6,684 - \$9,128
<b>Senior Industrial Hygienist</b>	\$10,118 - \$13,519

\*Junior and Assistant Safety Engineers receive a recruitment and retention pay differential of \$200 per month.

†Junior, Assistant, and Associate Safety Engineers receive geographic pay differential of \$250 per month if their worksite is located in Alameda, Marin, San Mateo, San Francisco, or Santa Clara counties. All employees in engineering classifications with 20 years or more of state service receive a longevity pay differential of +2% or more of their base salary.
