OPINION AND DECISION AFTER REMOVAL

(En Banc)

Upon a unanimous vote of its members, the Appeals Board issues this decision as an en banc decision.¹ (Lab. Code, § 115.)

We previously granted removal in these matters on our own motion to provide an opportunity to study and address the issues. On October 21, 2024, and to assist the parties further, the Appeals Board issued an en banc notice of status conference, which occurred on November 4, 2024.

At the status conference, the parties entered into stipulations resolving their underlying attorney fee dispute in these matters and requesting dismissal with prejudice of all petitions for removal and/or disqualification in these matters as relates to their attorney fee dispute. We have reviewed the stipulations and as our Decision After Removal, we will issue orders approving the stipulation to withdraw the petitions, and order dismissal of all petitions for removal and/or disqualification pending in these matters. The parties' stipulation in the underlying attorney fee

dispute may be submitted in each of these cases to the workers' compensation judge tasked with issuing the award of fees. Finally, having resolved all issues pending in these consolidated matters, we will issue an order rescinding the order of consolidation and return these matters to the trial level for further proceedings.

For the foregoing reasons,

IT IS ORDERED as the Decision After Removal of the Workers' Compensation Appeals Board, that the November 4, 2024 Stipulation of the parties to withdraw with prejudice all current petitions related to their attorney fee dispute, including petitions for disqualification, removal, penalties, sanctions, and attorney fees is **APPROVED**.

IT IS FURTHER ORDERED that pursuant to the November 4, 2024 stipulation, the petitions for disqualification and/or removal in each of these consolidated proceedings are **DISMISSED WITH PREJUDICE** as follows:

The Petition for Disqualification filed by Patrick Gorman in *Cal Demercurio, Jr. v. All Seasons Roofing*, (ADJ15760386, ADJ18891808);

The Petitions for Removal and Disqualification filed by Patrick Gorman in *Dawn Snure v. City of Mt. Shasta*, (ADJ19153721, ADJ16116250).
