DIRECTIONS FOR USE

Hydralinx Back2Blue Perfect Balance is used to raise calcium hardness in swimming pool water. Low calcium hardness causes etching of plaster and corrosion of metal parts. For these reasons, calcium hardness in swimming pool water should be maintained in the proper range.

The ideal range of Calcium Hardness in swimming pool water is between 150 and 300 mg/L. 110g Back2Blue PERFECT BALANCE per 10,000 litres of pool water will raise calcium hardness approximately 10 ppm.
