STORAGE AND DISPOSAL

Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to the spray tank. Do not dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the empty containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS

Harmful if swallowed. Will damage eyes. Will irritate skin. Avoid contact with eyes and skin. If product in eyes, wash it out immediately with water. Wash hands after use.
