SITUATION	APPLICATION RATE	CRITICAL COMMENTS
For general Insecticides, Herbicides, Fungicides		
High Volume Power Spray	100 mL per 100 L	Always consult the pesticide label for exact application rates.
Low Volume Boom Spray	40 mL per 100 L	
Misting Machine	5 mL per 5 L	
Knapsack	2 mL per 15 L	
For Contact Herbicides – e.g. Paraquat		Spray until stems and leaves are wet. These higher rates ensure the plants are thoroughly wetted.
High Volume Power Spray and Boom Spray	120 mL per 100 L	
Knapsack	20 mL per 15 L	
For Selective Herbicides – e.g. dms and tops	200-250 mL per 100 L	Using FARMALINX WetDrop Wetter outside pesticide label directions may reduce selectivity. DO NOT add FARMALINX WetDrop Wetter when mixing diclofop with a broadleaf herbicide.
Soil Residual Herbicides – e.g. diuron	100-400 mL per 100 L	See pesticide label for exact rates.

GENERAL INSTRUCTIONS

FARMALINX WetDrop Wetter

- Is a spray additive suitable for herbicides.
- Increases wetting and spray coverage.
- Is suitable for use with all types of water.
- Is suitable for high and low volume spraying.
- Is 100% active non-ionic surfactant
- Can be used with acid and alkaline sprays.

PREPARATION

Fill tank to at least half with water.

Add FARMALINX WetDrop Wetter and stir.

Add pesticide and stir. Top up tank with required amount of water. Stir until completely mixed.

DO NOT add directly to undiluted sprays containing wetting agents.

Only use wetter where directed on the pesticide label.

Refer to the label of the pesticide to be mixed with for further instructions.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

Toxic to fish. DO NOT contaminate streams, rivers and waterways with the chemical or used containers.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a cool well-ventilated area. DO NOT store for prolonged periods in direct sunlight.

For Non-Refillable Containers: Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean container to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If not available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

For Refillable Containers: Storage must be secure so that contents cannot be tampered with. All locks and/or seals must be in order. If locks or seals are broken prior to initial use then the integrity of this product cannot be assured. If this occurs FARMALINX Pty Ltd should be advised immediately. Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.
